4. A **MOTION** to purchase signage for Permit Only Parking Lots of \$1500 made by Brewer, seconded by Gorman. All were in favor. **MOTION** carried.

5. A **MOTION** to approve Police Directives 1.2.1 and 1.7.3 made by Bilotta, seconded by Rhodes. All were in favor. **MOTION** carried.
