APPROVAL OF BILLS TO BE PAID

A **MOTION** to approve the bills totaling \$58,389.09 to be paid made by Murphy, seconded by Gorman. All were in favor. **MOTION** carried.

ACTION ITEMS

2. A **MOTION** to approve the Teamsters Union Memorandum of Understanding up to \$250.00 clothing and or shoe reimbursement upon receipt made by Brewer, seconded by Rhodes. All were in favor. **MOTION** carried.
3. A **MOTION** to approve the Street Excavation Permit Fee Waiver for the Bangor Borough Authority made by Bilotta, seconded by Brewer. All were in favor. **MOTION** carried.

4. Manager Dysard went over the final budget with Council and answered a few questions Councilmembers had. Councilmember Houser has a concern about delinquent per capita taxes. Manager Dysard will discuss this matter further with Solicitor Ceraul. There were a few minor changes to the expenses.
5. A **MOTION** to Advertise of the 2016 Tax Ordinance #963 made by Brewer, seconded by Bilotta. Vote 7-1. Yay- Kresge, Gorman, Bilotta, Brewer, Rhodes, Murphy, LaBar. Nay-Houser. **MOTION** carried.
