A **MOTION** to approve the minutes dated January 9, 2017 & January 23, 2017 was made by Bilotta, seconded by Rhodes. All were in favor. **MOTION** carried.

APPROVAL OF BILLS TO BE PAID

A **MOTION** to approve the bills totaling \$234,924.51 to be paid was made by Goffredo, seconded by Gorman. All were in favor. **MOTION** carried.

ACTION ITEMS

1. Members from the Bangor Business Association were present to discuss three events that they are planning in Bangor Borough. The proposed events would be a car show on 6/24, community block party on 7/8 and a wine festival on 9/30. A **MOTION** was made by Rhodes, seconded by Goffredo to approve closing Broadway between 191 and South Main in addition to Murry Street for these proposed events. All were in favor, **MOTION** carried.
2. A **MOTION** was made by Rhodes, seconded by Gorman to appoint Sascha Gutierrez as Junior Council Person. All were in favor. **MOTION** carried.
3. A **MOTION** to adopt the Recreation Advisory Board Ordinance #969 was made by Goffredo, seconded by Gorman. All were in favor, **MOTION** carried.

4. Manager Dysard reported that three Audit RFP's were received (Campbell, Rappold & Yarasits, LLP, Zelenkofske Axelrod, LLC, and Maillie, LLP.) A **MOTION** to award the Audit RFP # 2017-01 to Maillie, LLP was made by Bilotta, seconded by Schweitzer. All were in favor, **MOTION** carried.

COUNCIL COMMENTS

1. Schweitzer commented that at the last Authority meeting preventative maintenance on the sewer lines was discussed.
2. Gorman mentioned that the Park Board is working on dates for the luau and movie.
3. Council President Kresge commented that everything in the town is improving and it's only going to get better because of people working together and getting things done.
4. Manager Dysard commented that Stephen Reider (director of SlateBelt Rising) was welcomed to the office last week.
5. Rhodes thanked the members from the Bangor Business Association for attending the meeting.
6. Bilotta also thanked the Bangor Business Association for attending and their work for improving the downtown.
