ORDINANCE NO. 973**

**AN ORDINANCE ADOPTING THE VEHICLES, TRAFFIC AND PARKING
REGULATIONS**

WHEREAS, after discussion Borough Council determined it is necessary to adopt this Ordinance to provide for the safe use of streets within the Borough, provide certain regulations and restrictions regarding the use of vehicles on streets and provide enforcement of violations,

NOW, THEREFORE, it is hereby **ORDAINED** and **ENACTED** by the Borough Council of the Borough of Bangor, County of Northampton and Commonwealth of Pennsylvania, as follows:

Article I. General Regulations

Section 1. Definitions and Interpretation.

- A. Words and phrases, when used in this Ordinance, except for sections or articles to which different or additional definitions apply, shall have the meanings ascribed to them in the Vehicle Code (the Act of June 17, 1976, P.L. 162 No. 81), as amended, except that, in this Ordinance, the word "street" may be used interchangeably with the word "highway," and shall have the same meaning as the word "highway" as defined in the Vehicle Code.
- B. The term "legal holidays" as used in this Ordinance shall mean and include: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day.
- C. In this Ordinance, the singular shall include the plural, the plural shall include the singular, and the masculine shall include the feminine.

Section 2. Manner of adopting permanent traffic and parking regulations.

All traffic and parking regulations of a permanent nature shall be enacted as ordinances, as parts of ordinances, as amendments to ordinances, or as amendments to this Ordinance, except where the law specifically authorizes less formal action.

Section 3. Continuation of existing regulations.

The provisions of this Ordinance, so far as they are the same as those of ordinances and regulations are in force immediately before the enactment of this Ordinance, are intended as a continuation of those earlier ordinances and regulations, and not as new enactments. Nothing in this Ordinance shall affect any act done or liability incurred, or any suit or prosecution pending or to be instituted under any of those repealed or superseded ordinances or regulations.

Section 4. Temporary and emergency regulations.

- A. The Mayor shall have the following powers to regulate traffic and parking temporarily and in time of emergency:
- (1) In the case of fire, flood, storm or other emergency, to establish temporary traffic and/or parking regulations; and
 - (2) In the case of emergency or to facilitate public works, or in the conduct of parades, processions or public events, to restrict or prohibit traffic and/or parking in limited areas for periods of not more than 72 hours.
- B. Such temporary and emergency regulations shall be enforced by the Police Department in the same manner as permanent regulations. Any person who shall operate or park a vehicle or tractor in violation of any such regulations, or who shall move, remove, destroy, injure or deface any sign or marking erected, posted or made to give notice of any such regulation, shall, upon conviction thereof, be subject to the penalty set forth in the law or elsewhere in this Ordinance for a violation of such nature, and, in case of a violation for which no specific penalty is set forth in the law or elsewhere in this Ordinance, to a fine of not more than \$25 together with costs of prosecution.

Section 5. Experimental regulations; violations and penalties.

The Borough Council may, from time to time by resolution, designate places upon and along the highways in the Borough of Bangor where, for a period of not more than 90 days, specific traffic and/or parking regulations, prohibitions and restrictions shall be in force and effect, and shall designate such locations by proper signs and markings. Such regulations, prohibitions and restrictions shall be effective as if they had been specified in this Ordinance. No person shall operate or park a vehicle or tractor in violation of any such regulation, prohibition or restriction, and no person shall move, remove, destroy or deface any sign or marking erected, posted or made by authority of this section. Any person who shall violate any provision of this section shall, upon conviction thereof, be subject to the penalty set forth in the law or elsewhere in this Ordinance for a violation of such nature, and in case of a violation for which no specific penalty is set forth in the law or elsewhere in this Ordinance, to a fine of not more than \$25 together with costs of prosecution; provided, the purpose of this section is to allow for the test and experimental determination of the feasibility and desirability of permanent changes in the ordinances of the Borough of Bangor relative to traffic and parking.

Section 6. Traffic on streets closed or restricted for construction, maintenance or special events.

- A. The Borough Council shall have authority to close any street or specific part of a street to vehicular traffic and to place barriers or station police officers at each end of the closed portion, while construction or maintenance work is under way or a special event is being conducted on the closed portion. It shall be unlawful for any person to drive a vehicle upon any such closed portion.
- B. The Borough Council shall have authority to establish a restricted traffic area upon any street where construction or maintenance work is underway and to station flagmen at each end of the restricted portion. It shall be unlawful for any person to drive a vehicle upon any such restricted traffic area at any time when the flagman is displaying a sign directing that vehicle to stop, or is signaling that vehicle, by a flag or other device, not to proceed.

- C. Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$25 and costs of prosecution.

Section 7. Crosswalks, Safety Zones, Traffic Lanes, Parking Spaces and Other Signs or Markings.

Borough Council or its designee shall have the power and authority to establish, change and abolish, and to designate by appropriate markings and/or signs, crosswalks, safety zones, traffic lanes and parking spaces, as well as to install signs and/or to place markings alerting drivers of provisions of the laws of Pennsylvania and of the Ordinances of the Borough.

Section 8. Authority of police officers.

The police officers of the Borough of Bangor are hereby authorized to direct traffic on the highways of the Borough and at intersections thereof and to otherwise enforce the provisions of this Ordinance.

Section 9. Authorization for use of speed timing devices.

- A. The Borough Police Department is hereby authorized to use all speed timing devices for the determination of speed of a motor vehicle as are approved or will be approved by the Department of Transportation of the Commonwealth of Pennsylvania, in accordance with Title 75 Pa.C.S.A. § 3368 as hereafter amended, supplemented, modified or reenacted.
- B. This section authorizes the use of said devices upon all highways within the Borough, be they Borough, county or state highways, and does also hereby elect to exercise all powers granted to "local authorities" under the Vehicle Code of the Commonwealth of Pennsylvania, Title 75 Pa.C.S.A. § 6101 et seq. (1977) as hereafter amended, supplemented, modified or reenacted by the General Assembly of Pennsylvania.

Article II. Traffic

Section 1. Motor Vehicles not to be driven on Sidewalks.

No person shall operate any motor vehicle longitudinally upon any sidewalk in the Borough, nor shall any person operate any such vehicle upon or across any sidewalk except in order to gain access to or egress from a driveway or alley at such location where the curb, if such sidewalk shall be curbed, shall have been properly cut down for the purpose.

Section 2. Traffic Signals at Certain Intersections.

At the following intersections, official traffic signals shall be erected (or if heretofore erected are hereby ratified), and traffic at such intersections may be directed by such signals:

1. Broadway and South First Street
2. Market Street and First Street
3. Pennsylvania Avenue and North First Street

Section 3. Speed Limits Established.

Except as otherwise established by law or ordinance, the following speed limits are hereby established: On all streets in the Borough within business districts, the speed limit shall be twenty-five (25) miles per hour. On all streets in the Borough within residential districts, the speed limit shall be twenty-five (25) miles per hour.

Section 4. One-Way Streets Established. The following are hereby established as one-way streets.

Section 5. Left Turns Prohibited at Certain Intersections.

It shall be unlawful for the operator of any vehicle or tractor, proceeding upon the first-named street, at any of the following intersections, in the direction hereby indicated, to make a left turn into the second-named street.

Section 6. Through Highways Established.

The following streets, or portions thereof, are hereby established as through highways, thus authorizing stop or yield signs to be erected facing traffic approaching every intersection with the through highway except for those intersections with traffic signals, or with exceptions or modifications as indicated below. Every driver of a vehicle approaching a stop or yield sign authorized by this section shall stop the vehicle or yield right-of-way as required by the Vehicle Code of the Commonwealth of Pennsylvania, 75 Pa.C.S.A.:

Section 7. Stop Intersections Established.

The following intersections are hereby declared to be stop intersections, and official stop signs shall be erected (or are hereby confirmed if heretofore erected) in such a position as to face traffic approaching the second-named street upon the first-named street, in the direction or directions hereby indicated. Every driver of a vehicle approaching the intersection upon the first-named street, in the direction or directions hereby indicated in each case, shall come to a full stop, within a reasonable distance, before entering such intersection:

Section 8. Commercial Vehicles Prohibited on Portions of Certain Streets; Exception.

It shall be unlawful for any person to operate any commercial motor vehicle upon any of the following portions of streets unless such vehicle shall have a destination within the limits of the Borough for the purpose of loading or unloading.

Section 9. Play Highways Authorized.

The Mayor is hereby authorized to designate as play highways, whenever he shall deem such action advisable, and for whatever period of time directed by him, any portion of any street or alley in the Borough, whereon sledding and coasting shall be permitted. Such play highway shall be set apart for the purpose under the direction of the Mayor. No person shall operate any motor vehicle or tractor upon any play highway at any time when such play highway shall be so designated, except in case of emergency, with special permission of the Mayor or police officer in charge, who shall first clear such play highway of all persons using the same for the purpose for which it was set aside. Any person who shall violate any provision of this Section shall, upon conviction thereof, be sentenced to pay a fine of not more than twenty dollars (\$20.00) and costs of prosecution.

Section 10. No turn on Red at Certain Intersections.

At the following intersections, official traffic signs shall be erected, (or if heretofore erected are hereby ratified), and it shall be unlawful for the operator of any vehicle or tractor, proceeding upon the first named street, at any of the following intersections, when the traffic signal shows red in the direction hereby indicated, to make a turn into the second named street.

Section 11. Enforcement.

Any operator of a vehicle who shall disobey or violate any of the provisions in this Article shall be subject to a fine and prosecution pursuant to the provisions of the Vehicle Code of the Commonwealth of Pennsylvania, Title 75 Pa. C. S. A.

ARTICLE III. Parking

Section 1. Parking Without Lights Authorized.

The boundary limits of the Borough of Bangor are hereby established as a zone in which motor vehicles may remain standing without lights, and all highways, streets, and alleys within such boundary limits are hereby designated as streets where motor vehicles may remain standing without lights.

Section 2. Vehicles to Park Within Marked Spaces.

Wherever a space shall be marked off on any street or alley for the parking of an individual vehicle, every vehicle there parked shall be parked within the lines bounding such space, and it shall be a violation of this article for any person to park a vehicle or allow it to remain parked otherwise.

Section 3. Parking Prohibited in Certain Locations.

Parking shall be prohibited at all times in the following locations:

Section 4. Parking Prohibited in Certain Locations Certain Days and Hours.

It shall be unlawful for any person to park a vehicle, or to allow the same to remain parked, in any of the following locations, at any time between the hours and on the days hereby indicated therefore:

Section 5. Parking Prohibited in Certain Locations at All Times During Period Between December 15 and March 31.

Parking is prohibited at any and all times during the period beginning December 15 and ending March 31 of the following year:

Section 6. Parking Time Limited in Certain Locations Certain Days and Hours.

It shall be unlawful to park a vehicle or to allow the same to remain parked, in any of the following locations, at any time hereby respectively stated, for longer than the maximum length of time hereby specified.

Section 7. Parking of Trucks with Trailers or Truck Trailers, Buses, Motorhomes and Certain Other Vehicles Prohibited.

It shall be unlawful for any person or entity to park, or to allow to remain parked, on any street or alley in the Borough, any vehicle bearing commercial plates, tri-axle vehicles, box trucks over twenty (20) feet in length, flat or box trailer, truck with trailer, truck trailer of any kind, tractor or rig, bus, motorhome, limousine, recreational trailer, snow mobile, farm equipment, boat or heavy construction equipment; provided, that it shall be lawful to park heavy construction equipment on a Borough street

or alley if a permit has been issued for such construction or demolition project and such equipment is at the permitted site. This prohibition shall not apply to any emergency vehicle/truck during an emergency, or any vehicle/truck temporarily parked, for a period of less than eight (8) continuous hours in one (1) day to service a residential zone (i.e. moving trucks) or to load/unload a motorhome or trailer.

Section 8. Parking Prohibited on Borough Streets, Alleys and Borough Property to Facilitate Vehicle Repairs or Maintenance.

It shall be unlawful to park a vehicle or allow the same to remain parked at any time upon any street, alley or Borough property in the Borough in order to facilitate repairing or maintenance of such vehicle.

Section 9. Bus Stops.

Bus stops are hereby authorized and created at such locations as shall be determined, fixed and appropriately marked by the Mayor. It shall be unlawful for any person to park any vehicle, other than a bus engaged in loading, unloading or awaiting passengers, in a bus stop at any time.

Section 10. Special Purpose Parking Zones Established; Parking Otherwise Prohibited.

The following are established as special purpose parking zones, and it shall be unlawful for any person to park a vehicle or to allow it to remain parked, in any such zone, except as specifically provided for that zone:

Section 11. Parking of inoperable vehicles or repair of vehicles.

- A. No person shall park or leave on the streets, highways or public property of the Borough any mechanically inoperable vehicle or vehicles without current registration plates.
- B. Repair or servicing of vehicles on streets, highways or public property of the Borough shall be prohibited.

Section 12. Parking of illegally registered or uninspected vehicles.

- A. No person shall park or leave on the streets, highways or public property of the Borough any vehicle without a current inspection sticker unless the vehicle is legally parked in front of, or in close proximity to, an official state inspection station in which identifies said vehicle by work order specifying a state inspection will be performed within twenty-four (24) hours. Additional work orders beyond the initial twenty-four (24) hour period are strictly prohibited.

- B. All vehicles parked on any street, highway or public property of the Borough shall have a current registration with the Pennsylvania Department of Transportation.

Section 13. Storage of vehicles on streets.

No vehicle shall be stored or parked in one place, upon any street, continuously for over seventy-two (72) hours.

Section 14. Penalty for Violations.

The police officer or other parking enforcement personnel of the Borough shall place on or attach to the vehicle a notice to the owner or driver of the vehicle that the vehicle was parked in violation of this Article, and instructing the owner or driver to deliver or mail to the Police Department of Borough Bangor the fine of twenty dollars (\$20.00), except that the following increased fines apply for the Sections indicated:

Section 7, a fine of fifty dollars (\$50.00)

Section 12, a fine of twenty five dollars (\$25.00)

Section 13, a fine of thirty five dollars (\$35.00)

Every twenty four (24) hours during which a violation continues after a Notice of Violation/Parking Ticket has been issued, shall be deemed a separate offense.

Failure to remit payment for fines within seven (7) calendar days will result in the issuance of a citation against the owner or person responsible for the violation, in accordance with the Pennsylvania Rules of Criminal Procedure, and upon conviction by the District Magistrate additional fines and costs will be levied. Should any fines levied by the court not be paid in the time prescribed a warrant may be issued for arrest and the vehicle will be subject to seizure and impoundment.

Any vehicle parked in violation of the provisions of this Article may be removed by any member of the Bangor Police Department, or the Department's designee. Any vehicle removed may be towed to, and placed at, any area designated by the Borough Manager or Chief of Police, or her/her designee, as the location for impounding of vehicles. All fines and costs for removal, towing, storage or parking of any vehicle removed under the provisions of this Article shall be paid by the owner of the vehicle, and the vehicle shall remain impounded until all costs are paid.

ARTICLE IV. Parking Meters

Section 1. Parking Meter Zones Established; Conditions for Parking

Parking meters shall be installed, operated, maintained, policed and supervised on the following restricted streets and Borough owned parking lots herein designated and described as parking meter zones, to provide proper parking spaces upon payment of a proper United States coin, at the rate of twenty five cents (25¢) per hour and such fractions thereof and multiples thereof as the individual parking meters shall indicate:

The hours of operation of parking meters in all parking meter zones shall be from 9:00 a.m. to 7:00 p.m. This shall not apply in any parking meter zones heretofore established on Sundays. Free parking shall be provided on all legal holidays.

Section 2. Placement and Characteristics of Parking Meters.

Meters installed in the afore-designated zones shall be placed upon the sidewalk/pavement immediately adjacent to the individual parking places. Each meter shall be placed in a manner to show what the parking space is, or is not legally occupied, and shall indicate the legal parking time established by the Borough, the unexpended period of legal parking, and on the expiration of such period of legal parking shall indicate illegal, or over-parking.

Section 3. Manner of Parking at Meters.

Each parked vehicle shall be parked so that its front shall be nearest to the parking meter, and each separate parking space shall be marked with lines at the front and rear. It shall be a violation of this article to park any vehicle of a lesser overall length than the designated area in such a position that such vehicle shall not be completely within the space provided for one vehicle. For meters placed in parking lots each vehicle must be parked fully within the designated parking space and shall not park in a manner crossing any lines delineating a parking space which would prohibit use of any adjacent parking space.

Section 4. Coin deposit in meter; overtime parking unlawful.

Whenever a vehicle is to be parked in any space adjacent to a parking meter, at any time in the period of limited parking as prescribed in this article, the driver of the vehicle, upon entering the parking space, shall immediately deposit, or cause to be deposited, in the parking meter, one or more coins of the United States of America as specified in the legend on the parking meter. Upon the deposit of the coin or coins, and placing the meter in operation, the parking space may be lawfully occupied by the vehicle for the time indicated on the meter. If any vehicle shall remain in any such parking space for such length of time that the meter shall indicate by proper signal that the lawful parking time has expired, that vehicle shall be

considered as having been parked overtime, and the parking of a vehicle overtime shall be a violation of this article.

Section 5. Unlawful to deposit substitute for coin in meter.

It shall be unlawful for any person to deposit in any parking meter installed under the provisions of this article any slug or other substitute for a coin of the United State of America.

Section 6. Unlawful to deposit coin in meter to extend parking time beyond legal limit.

It shall be unlawful and a violation of this article for any person to deposit or cause to be deposited, in any parking meter installed under the provisions of this article, any coin for the purpose of increasing or extending the parking time of any vehicle beyond the legal parking time allowing in the parking meter zone.

Section 7. Unlawful to remain parked at meter showing violation.

It shall be unlawful, and a violation of this article, for any person to permit a vehicle to remain in a parking space adjacent to a parking meter installed under this article, when that meter displays a signal indicating that the vehicle has already been parked there beyond the period of time prescribed for that parking space, or the time for which a coin/s was deposited in that meter for the parking of the vehicle.

Section 8. Unlawful to Tamper with Meters.

It shall be unlawful and a violation of this Article to tamper with any parking meter or to manipulate, or attempt to manipulate any such meter in such manner as to stop or extend the parking time without the required deposit of the coin or coins. Each and every parking meter is hereby declared to be Borough property, and breaking, destroying or defacing any such meter is a violation of this ordinance, any may be prosecuted according to the laws of the Commonwealth in such case made and provided.

Section 9. Ticketing of vehicles parked unlawfully.

It shall be the duty of the police officers and parking enforcement personnel of the Borough to ticket vehicles parked unlawfully by placing are attaching to the vehicle a notice to the owner or driver of the vehicle that the vehicle is in violation of this article, and instructing the owner or driver to pay a fine for the violation, that timely payment will save the violator from prosecution and from payment of additional fines as prescribed in this article.

Section 10. Exceptions.

The Borough shall have authority to establish no-park or special-purpose parking zones within any parking meter zone, and to remove parking meters from those areas as previously installed there, and the provisions of this article shall not apply in those areas where no-parking or special-purpose parking are in effect.

Section 11. Violations and Penalties.

- A. The police officer of other parking enforcement personnel of the Borough shall place on or attach to the vehicle a notice to the owner or driver of the vehicle that the vehicle was parked in violation of this Article, and instructing the owner or driver to deliver or mail to the Police Department of Borough Bangor the sum of ten dollars (\$10.00) within seven (7) calendar days after the date of such notice of violation, failure to pay within the time prescribed shall result in prosecution and penalties as set forth in Section 11.B.

- B. Failure to remit payment for fines within seven (7) calendar days will result in the issuance of a citation against the owner or person responsible for the violation, in accordance with the Pennsylvania Rules of Criminal Procedure, and upon conviction by the District Magistrate additional fines and costs will be levied. Should any fines levied by the court not be paid in the time prescribed a warrant may be issued for arrest and the vehicle will be subject to seizure and impoundment.
- C. Any vehicle parked in violation of the provisions of this Article may be removed by any member of the Bangor Police Department, or the Department's designee. Any vehicle removed may be towed to, and placed at, any area designated by the Borough Manager or Chief of Police, or her/her designee, as the location for impounding of vehicles. All fines and costs for removal, towing, storage or parking of any vehicle removed under the provisions of this Article shall be paid by the owner of the vehicle, and the vehicle shall remain impounded until all costs are paid.

ARTICLE V. Snow and Ice Emergency

Section 1. Definitions.

- A. "Snow" shall mean any precipitation depositing any accumulation on the streets, including snow, sleet, hail, ice and freezing rain.
- B. "Snow Emergency" shall mean a state of highway conditions resulting from eight inches (8") of snow or one-quarter inch (1/4") of freezing precipitation that are hazardous and dangerous to vehicular and pedestrian traffic and so declared by the Mayor.
- "Snow Emergency Routes" shall mean all streets in the Borough so designated and marked.
- D. "Chains" shall mean full chains, strapped chains or other types of chains mounted on both drive wheels of a motorized vehicle.
- E. "Mud and Snow Tires" shall mean tires having treads designed for use in snow, which tires must be in such conditions as to serve the

Section 2. General Provisions.

- A. There shall be no parking on either side of the following streets during the declaration of a snow emergency:

North First Street from Market Street to the North Borough boundary.

South First Street from Market Street South to the Borough boundary.

North Main Street from Market Street North to the Borough boundary.

South Main Street from Market Street South to Broadway.

State Route 512 (a.k.a. Erdman Avenue) from South Main Street East to the Borough boundary.

Broadway from South Main Street West to South Eighth Street.

Market Street from Main Street West to the Borough boundary.

Messinger Street from South First Street East to Center Street.

South Main Street from Messinger Street South to Market Street.

- B. There shall be no parking on the side of the following street specified during the declaration of a snow emergency:

 Pennsylvania Avenue from North Main Street West to North Eighth Street - No parking on the North side of the street.

- C. All such streets designated as snow emergency routes shall be posted with suitable signs or markers at intervals not exceeding six hundred (600) feet, which signs or markers shall bear the words snow emergency route.
- D. When, in the opinion of the Mayor, the actual or expected precipitation of snow will create hazardous or dangerous highway conditions for vehicular or pedestrian traffic, he/ she shall have authority to declare a snow emergency. For purposes of this paragraph, the Mayor should consult with the Borough Manager, Police Chief, Fire Chief, Assistant Fire Chief or Street Department Supervisor prior to declaring said snow emergency.
- E. The Mayor, or his/her designee, shall immediately inform the public of the snow emergency by issuing a press release to the local newspaper and radio.

Such declaration of a snow emergency shall not go into effect until at least four (4) hours after announced, and shall remain in effect until terminated by the Mayor, or his/ her designee.

- G. Within four (4) hours after a snow emergency has been declared, and during its existence:

- (1) No vehicle shall be parked on a snow emergency route unless the snow emergency route signs permit certain parking.
- (2) Any person who drives a vehicle without chains or snow tires upon any street designated as a snow emergency route and such vehicle becomes stalled or incapable of moving under its own power or anyone who leaves such vehicle unattended shall be in violation of this Ordinance and shall be subject to the penalty set forth below.
- (3) Any vehicle parked, stalled, incapable of moving under its own power or left unattended upon any street designated as a snow emergency route may be removed or towed away to any other location by the Police Department or its authorized agent as provided by law or Ordinance of the Borough of Bangor.
- (4) The Mayor may declare any snow emergency route or any part of a snow emergency route to be free from the restrictions herein imposed when, in his/her opinion, the weather or street conditions warrant such an exclusion. The Mayor shall give notice of this determination in the manner provided for in subsection (E) above.
- (5) Nothing in this section shall be construed to permit parking at any time or place where it is forbidden by other provisions of law.

Section 3. Penalty.

Any person who shall violate any provisions of this Article shall pay a fine of fifty dollars (\$50.00). Failure to remit payment for fines within seven (7) calendar days will result in the issuance of a citation against the owner or person responsible for the violation, in accordance with the Pennsylvania Rules of Criminal Procedure, and upon conviction by the District Magistrate additional fines and costs will be levied. Should any fines levied by the court not be paid in the time prescribed a warrant may be issued for arrest and the vehicle will be subject to seizure and impoundment.

ARTICLE VI. Interpretation and Repeal

Section 1. Severability.

The provisions of this Ordinance shall be severable, and if any of its provisions shall be held to be unconstitutional, illegal or invalid, such decision shall not affect the validity of any of the remaining provisions of this Ordinance. It is hereby declared as a legislative intent that this Ordinance would have been adopted and such unconstitutional, illegal or invalid provisions not be included therein.

Section 2. Provisions to be Continuation of Existing Regulations.

The provisions of this Ordinance, so far as they are in the same character as those of ordinances and regulations in force immediately prior to the enactment of this Ordinance, are intended as a continuation of such ordinances and regulations. All relevant ordinances, regulations, and policies of the Borough of Bangor not amended or repealed shall remain in full force and effect.

Section 3. Effective Date.

This Ordinance shall become effective concurrently herewith.

Section 4. Repeal of conflicting Ordinances.

Any Ordinance or part of an Ordinance conflicting with the provisions of this Ordinance shall be and the same in hereby repealed to the extent of such conflict.

Section 5. Repeal of Certain Prior Ordinances.
