ORDINANCE NO. 979**

**AN ORDINANCE REGARDING THE REQUIREMENT OF A PERMIT
FOR THE MOVEMENT OF HOUSEHOLD GOODS, COMMONLY
KNOWN AS A MOVING PERMIT, WITHIN, IN OR OUT OF THE
BOROUGH, ESTABLISHING PERMIT AND FEE PROCEDURES,
PRESCRIBING PENALTIES FOR VIOLATION THEREOF,
REPEALING ALL INCONSISTENT ORDINANCES AND
ESTABLISHING AN EFFECTIVE DATE**

NOW, THEREFORE, it is hereby **ORDAINED** and **ENACTED** by the Borough Council of the Borough of Bangor, County of Northampton and Commonwealth of Pennsylvania, as follows:

Section 1. Permit Required

No person or persons, firm, or corporation shall move or cause to be moved from any place outside the Borough of Bangor to any place within the Borough, or from any place within the Borough to another place therein or to any place beyond the limits of the Borough, any household goods or other goods, wares of merchandise in bulk without first securing from the Borough office a permit for such moving or transportation.

Section 2. Application for Permit

Any person or persons, firm, or corporation requiring such a permit for the removal or transportation of household goods in the manner above described in Section 1, shall make application to the Borough Manager or his/her designee setting forth the applicants name and address and also setting forth the names of the owners or reputed owners of the property to be moved, the address and location from which the property is to be removed, and the new address of location of the place to which the property is to be moved.

Section 3. Fees

Prior to issuance of said permit, a fee, for which a charge in an amount to be established from time to time by resolution of Borough Council, shall be made to the Borough Manager or his/her designee.

Section 4. Issuance of Permit

The Borough Manager or his/her designee shall, upon application being made as provided for in Section 2 of this Ordinance and fee being paid as provided for in Section 3 of this Ordinance, issue a permit, setting forth the name or names of the permittee as well as the name or names of

the owners of the goods to be moved and the address from which the goods are to be moved and the address to which the goods are to be delivered.

Section 5. Violations and Penalties

Any person violating any of the provisions of this Ordinance shall, upon conviction in a summary proceeding before a District Magistrate, be sentenced to pay a fine of not more than \$500.00 and costs of prosecution and, in default of payment of such fine and costs, to incarceration in the County prison for not more than 30 days.

Section 6. Repealer

Any Ordinance or part of an Ordinance conflicting with the provisions of this Ordinance shall be and the same is hereby repealed to the extent of such conflict; specifically repealing Ordinances:

- #441, enacted May 7, 1956
- #578, enacted November 8, 1971
- #769, enacted January 1991
- #906, enacted January 8, 2007

Section 7. Severability

If any section, sub-section, provision, regulation, limitation, restriction, sentence, clause phrase or word in this Ordinance is declared by any reason to be illegal, unconstitutional, or invalid by any court of competent jurisdiction, such decision shall not affect or impair the validity of this Ordinance as a whole, or any other section, sub-section, provision, regulation, limitation, restriction, sentence, clause, phrase, word or remaining portion of this Ordinance. Borough Council hereby declares that it would have adopted this Ordinance and each section, sub-section, phrase and word thereof, irrespective of the fact that any one or more of the sections, sub-sections, provisions, regulations, limitations, restrictions, sentences, clauses, phrases or words may be declared illegal, unconstitutional or invalid.

Section 8. Effective Date

This Ordinance shall take effect immediately upon its adoption.
