**ACTION ITEMS:**

1. A **MOTION** to approve payment of the bills totaling \$240,040.55 to be paid was made by Bilotta, seconded by Fogel. All were in favor. **MOTION** carried.
2. Manager Dysard reported that an application form was received for a handicapped parking sign from Arlene Compton at 324 Broadway. The resident does have a handicap license plate. A **MOTION** was made by Capone, second by Fogel to approve the handicap parking sign application. All were in favor. **MOTION** carried.
3. Manager Dysard discussed “clean up” Ordinance #989 (Repealing Inconsistent and Outdated Ordinances) with Council. A **MOTION** was made by Goffredo, seconded by Augustine to authorize advertisement of Ordinance # 989. All were in favor. **MOTION** carried.
4. Manager Dysard and Council discussed the Curb and Sidewalk Ordinance #990. This pertains to standards for the construction, replacement and maintenance of sidewalk, curb, depressed curb and driveway aprons. This Ordinance will repeal all prior Ordinances and establish a single modern Ordinance with current construction standards. A **MOTION** was made by Goffredo, seconded by Bilotta to authorize advertisement of Ordinance # 990. All were in favor. **MOTION** carried.
5. Manager Dysard reported that a letter was received from Liberty Fire Co. regarding the 2017 LSA grant. Members from Liberty were present to discuss this with Council and answer questions. A **MOTION** was made by Schweitzer, seconded by Fogel to recommend Liberty’s request for the one-year grant extension, pending the timeline and budget information be submitted from Liberty Fire Company. All were in favor, **MOTION** carried.

**COUNCIL COMMENTS:**

1. Mayor Kerzner updated Council on her recent duties as Mayor.
2. Council Member Fogel updated Council on upcoming events at the Slate Belt YMCA.
3. Council Member Capone stated that the first Park Board Meeting of the year will be held in March.
4. Council Member Goffredo thanked Chief Felchock again for his safety and security assistance with his parish.

5. Council President Kresge updated Council regarding his recent meeting with BASD and asked Council Member Capone to accompany him at the next meeting to discuss encouraging students to get involved in events held by the Park Board.
