ORDINANCE NO. 969

AN ORDINANCE OF THE BOROUGH OF BANGOR CREATING THE BANGOR BOROUGH RECREATION ADVISORY BOARD, REPEALING ORDINANCE NO. 921 AND ABOLISHING ANY PRIOR ORDINANCE OF THE BOROUGH DEALING WITH RECREATION BOARDS OR PARK BOARDS WITHIN THE BOROUGH, AND PROVIDING FOR THE MEMBERSHIP AND DUTIES OF THE BANGOR BOROUGH RECREATION ADVISORY BOARD.

BE IT ORDAINED AND ENACTED by the Borough Council of the Borough of Bangor, it is hereby ordained and enacted by the authority of the same as follows:

Section 1: Bangor Borough Recreation Advisory Board is hereby created by this Ordinance.

Section 2: Duties of the Bangor Borough Recreation Advisory Board are as follows:

- a. To assist in developing a comprehensive recreation plan for the Borough of Bangor that encompasses all recreational areas within the Borough of Bangor.
- b. Advise, and give recommendations to, Bangor Borough Council on all recreational matters dealing with all recreational areas within the Borough limits.
- c. Plan and organize activities and events that promote recreation and/or use of Borough recreational areas, in coordination with the Borough Manager and Borough Council.

Section 3: By-Laws: The Bangor Borough Recreation Advisory Board shall be governed by By-Laws which shall be submitted to Bangor Borough Council for adoption by Resolution, and for amendment from time to time by Resolution.

Section 4: Membership and tenure of the Board: The Bangor Borough Recreation Advisory Board shall consist of seven (7) residents of the Borough of Bangor

- a. All Board members shall serve without compensation.
- b. All members appointed shall serve at the pleasure of Borough Council.

Section 5: All members of the Bangor Borough Recreation Advisory Board shall be held in public pursuant to the provisions of the Pennsylvania Sunshine Law, as amended. A quorum shall be required for the Board to conduct business at public meetings. Members shall be appointed by the Bangor Borough Council for a term of five (5) years. Ordinance No. 921 and any other ordinances of the Borough of Bangor dealing with the creation of a Park Board, a Recreation Board, or other similar entity, are hereby repealed and abolished in their entirety.

Section 6: This Ordinance shall be placed into effect immediately upon enactment hereof.
