- **3.** A *MOTION* to appoint James Kresge to the Civil Service Commission term ending 12/31/17 made by Schweitzer, seconded by Rhodes. All were in favor. *MOTION* carried.
- **4.** A *MOTION* to appoint Michael Bauer to the Civil Service Commission term ending 12/31/18 made by Rhodes, seconded by LaBar. All were in favor. *MOTION* carried.
- 5. A *MOTION* to appoint Kelly Rak to the Civil Service Commission term ending 12/31/19 made by Rhodes, seconded by LaBar. All were in favor. *MOTION* carried.
- 6. A *MOTION* to reduce the number of seats on the Borough Authority from 7 to 5 made by Schweitzer, seconded by Bilotta. All were in favor. *MOTION* carried.
- **7.** A *MOTION* to eliminate the two restricted seats pending approval of the Authority Board and allowing the Solicitors to work out implementations. All were in favor. *MOTION* carried.

8. Manager Dysard gave a detailed description on the upcoming 2017 budget. There is a 3% purposed tax increase for the 2017 year. Real Estate tax is one of the primary sources of Revenue for municipalities. He also spoke about changing the lighting throughout the Borough and this could potentially lead up to a large cost savings for the Borough.
