#### CALL TO ORDER AND PLEDGE TO FLAG

- 2. Anna Maria Caldara was present to give Council information regarding feral cats.
- 3. Ann Miller was present from 318 Market Street regarding her property maintenance concern from last month (306 Market Street). Manager Dysard commented that action was taken, and he will follow up with Code Enforcement.
- 4. Leila Ross (129 Messinger Street) was present to thank the borough for the Messinger Street Culvert Project.

### **APPROVAL OF MINUTES**

A **MOTION** to approve the minutes dated July 8, 2019 was made by Bilotta, seconded by Engle. All were in favor. **MOTION** carried.

#### **APPROVAL OF BILLS TO BE PAID**

A **MOTION** to approve the bills totaling \$275,667.60 to be paid was made by Engle, seconded by Fogel. All were in favor. **MOTION** carried.

# **ACTION ITEMS**

- 1. A **MOTION** to accept police directives #1.3.2 (Regulations & Discipline) and #1.3.5 (Allegation of Misconduct & Internal Affairs) was made by Gorman, seconded by Engle. All were in favor. **MOTION** carried.
- 2. Manager Dysard discussed the 2019 road paving bids with Council. A MOTION to award the 2019 road program bids contract to the low bidder Bracalente Construction for \$85,784.80 for the Chestnut and Park Avenue (15ft wide) bid options of the project was made by Bilotta, seconded by Fogel. All were in favor. MOTION carried. A MOTION to authorize the award for the partially CDBG grant funded project contract to Northeast Site Contractors, with the option for the Borough Manager to remove the High Street bid, if necessary (including base bid) for \$102,340.21 was made by Bilotta, seconded by Engle. All were in favor. MOTION carried.
- 3. Manager Dysard reported that Ott Consulting is recommending approval of payment request #7 for Grace Industries (Messinger Street Culvert Project). A **MOTION** was made by Fogel, seconded by Engle to approve payment request #7 in the amount of \$99,367.94. All were in favor. **MOTION** carried.
- 4. A **MOTION** was made by Engle, seconded by Bilotta to table the updated Junior Council Person Resolution pending the review of the Borough's Junior Council Members. All were in favor. **MOTION** carried.

# **COUNCIL COMMENTS**

- 1. Council Member Fogel reported that the YMCA Summer Food Program was a success.
- 2. Council Member Bilotta thanked Council Member Gorman for her years serving on Borough Council and Junior Council Member Neetz for serving on the Board.
- 3. Mayor Kerzner updated Council on the current issues involving the potential closing of Main Street Market.
- 4. Junior Council Member Gutierrez wished Neetz and Gorman well in their future endeavors.
- 5. Junior Council Member Neetz thanked Council for giving her the opportunity to serve on the Board.
- 6. Council President Kresge stated that the Liberty Carnival and Roseto Big Time was a success. Council President Kresge mentioned the recent death at the quarry and advised people to stay away from that area.

The County will be hosting a presentation at the Blue Valley Farm Show on how to operate the new voting machines.

Kresge thanked Neetz and Gorman for serving on the Board.
