2. Nominations for appointment to the Borough Council with a term to expire on 12/31/2021 were accepted. A **MOTION** to nominate James Augustine was made by Goffredo, seconded by Engle. A **MOTION** to nominate Amy Herkalo was made by Bilotta, seconded by Schweitzer. A **MOTION** to close the nominations was made by Schweitzer, seconded by Goffredo. A Roll Call Vote was taken:

  - Schweitzer - Herkalo.Vote Tally: 3-Augustine, 2-Herkalo. **MOTION** to appoint James Augustine to Borough Council with a term to expire on 12/31/2021 carried.
3. A **MOTION** was made by Schweitzer, seconded by Bilotta to appoint James Kresge to the Authority Board with a term to expire on 12/31/2022. 4 in favor, 1 abstention (Kresge) **MOTION** carried.
4. A **MOTION** was made by Schweitzer, seconded by Goffredo to appoint Robert Engle to the Authority Board with a term to expire on 12/31/2023. All were in favor. **MOTION** carried.
5. A **MOTION** was made by Engle, seconded by Bilotta to appoint Edmund Wojtkowski to the Planning Commission Board with a term to expire on 12/31/2022. All were in favor, **MOTION** carried.

6. Nominations for appointment to the Planning Commission with a term to expire on 12/31/2020 were accepted. A **MOTION** to nominate Marissa Donnelly to the Planning Commission was made by Goffredo, seconded by Engle. A **MOTION** to close nominations was made by Schweitzer, seconded by Goffredo. All were in favor. **MOTION** to appoint Marissa Donnelly to the Planning Commission for a term to expire on 12/31/2020 carried.
7. A **MOTION** was made by Engle, seconded by Schweitzer to appoint Amy Herkalo to the Park Board with a term to expire on 12/31/2019 and the Zoning Hearing Board with a term to expire on 12/31/2023. All were in favor. **MOTION** carried.
8. Manager Dysard discussed the draft 2020 Borough and Authority budgets with Council and answered questions.
