ORDINANCE NO. 982

AN ORDINANCE FIXING THE COMPENSATION OF MEMBERS OF THE BOARD OF THE BANGOR BOROUGH AUTHORITY AND PROVIDING FOR THE PAYMENT OF SAID COMPENSATION ONLY FOLLOWING THE BOARD MEMBERS ATTENDANCE AT THE MONTHLY AUTHORITY MEETING, REPEALING ALL INCONSISTENT ORDINANCES AND ESTABLISHING AN EFFECTIVE DATE.

NOW, THEREFORE, it is hereby **ORDAINED** and **ENACTED** by the Borough Council of the Borough of Bangor, County of Northampton and Commonwealth of Pennsylvania, in a regular meeting assembled, as follows:

SECTION 1.

The compensation of the Members of the Bangor Borough Municipal Authority Board, created under the Pennsylvania Municipality Authorities Act of 1945 enacted by Ordinance and approved July 6, 1959, is hereby fixed and determined, in accordance with said Act, as amended, at a rate set per Authority Board meeting by Resolution of Borough Council as adopted from time to time, provided, however, that said compensation shall be paid for not more than one (1) meeting per month, and that said salary shall be paid from Authority funds.

SECTION 2.

Said compensation shall only be paid to those Authority Board Members actually in attendance at the monthly meeting of the Authority. Those Board Members who do not attend the monthly meeting of the Authority shall receive no compensation for said meeting. As the compensation is intended for a Member's attendance at a monthly meeting, should there be no meeting of the Authority in any given month, for whatever reason, no Board Members shall receive compensation for that month. Should a meeting be scheduled, but thereafter cancelled after the Members convene for a lack of Quorum, those members in attendance shall receive compensation for attendance at said meeting.

SECTION 3.

Any and all Ordinances or parts of Ordinances which are clearly inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4.

If any section, sub-section, provision, regulation, limitation, restriction, sentence, clause phrase or word in this Ordinance is declared by any reason to be illegal, unconstitutional, or

invalid by any court of competent jurisdiction, such decision shall not affect or impair the validity of this Ordinance as a whole, or any other section, sub-section, provision, regulation, limitation, restriction, sentence, clause, phrase, word or remaining portion of this Ordinance. Borough Council hereby declares that it would have adopted this Ordinance and each section, sub-section, phrase and word thereof, irrespective of the fact that any one or more of the sections, sub-sections, provisions, regulations, limitations, restrictions, sentences, clauses, phrases or words may be declared illegal, unconstitutional or invalid.

SECTION 5.

This Ordinance shall take effect immediately upon its adoption.
