# BOROUGH OF BANGOR COUNTY OF NORTHAMPTON COMMONWEALTH OF PENNSYLVANIA ORDINANCE NO. 989

# AN ORDINANCE OF THE BOROUGH OF BANGOR, NORTHAMPTON COUNTY, PENNSYLVANIA, REPEALING INCONSISTENT AND OUTDATED ORDINANCES THAT ARE NO LONGER RELEVANT AND ESTABLISHING-AN-EFFECTIVE-DATE

**NOW, THEREFORE**, it is hereby **ORDAINED** and **ENACTED** by the Borough Council of the Borough of Bangor, County of Northampton and Commonwealth of Pennsylvania, as follows:

## Section 1. Repealing Inconsistent and Outdated Ordinances

Any Ordinance or part of an Ordinance conflicting with the provisions of this Ordinance shall be and the same is hereby repealed to the extent of such conflict; specifically repealing Ordinances:

#12, enacted November 22, 1897

An Ordinance relative to coasting on certain streets

#13, enacted November 22, 1897

An Ordinance regulating the rate of speed at which trains & locomotives or electric cars may be run through the streets of the Borough of Bangor.

#19, enacted January 3, 1889

An Ordinance providing that "Worldly employment of business on Sunday Prohibited"

#24, enacted November 22, 1897

An Ordinance to prevent any undue quantity of powder or other explosive being stored within the limits of the Borough of Bangor

#28, enacted January 3, 1898

An Ordinance relative to the establishment of market days within the Borough and fixing a penalty for non-compliance therewith

#32, enacted May 10, 1898

An Ordinance relative to the assessment of taxes and how it is to be appropriated

#33, enacted May 10, 1898

An Ordinance making an appropriation to the health board of the Borough of Bangor

#34, enacted December 21, 1898

An Ordinance relative to lighting the streets of the Borough of Bangor

#### #36, enacted March 29, 1899

An Ordinance granting a right or way through certain streets of the Borough of Bangor to the Slate Belt Electric Street Railway Company, imposing certain conditions, providing certain penalties and prohibiting certain acts.

## #37, enacted May 17, 1899

An Ordinance authorizing the issuing or bonds of the said Borough to the amount of twelve thousand dollars, payable thirty years after the date thereof

## #39, enacted August 14, 1899

An Ordinance relative to the granting to companies using or occupying any public street, lane or alley of the Borough of Bangor the distribution of gas, water, electricity, oil or other fluid, material or substance, or any of the same by means of pipes laid in any street, lane or alley.

## #40, enacted August 14, 1899

An Ordinance granting consent to the Bangor Gas Company to enter upon the streets, lanes, alleys & highways of the Borough of Bangor with its main pipes and lines of distribution for gas for the purposes thereof and to lay, inspect, alter & repair the same.

## #43, enacted April 2, 1900

An Ordinance declaring the rights and privileges granted to the Slate Belt Electric Street Railway Co & its successors and assigns to locate, construct, reconstruct, maintain & operate a single track railway, together with certain turnouts, turntables, curves, loops and switches, in, over & along certain streets of the Borough of Bangor, PA, upon certain conditions, forfeited & that said grant null & void, & repealing the ordinance granting the same

#### #44, enacted May 7, 1900

An Ordinance laying and assessing a tax for General Fund, Road & Sinking Fund Tax

#### #49, enacted February 11, 1901

An Ordinance repealing Ordinance #28 entitled "An ordinance relative to the establishment of market days within the Borough & fixing a penalty for non-compliance therewith"

#### #52, enacted June 3, 1901

An Ordinance laying and assessing a tax for General Fund, Roads and Sinking Fund Tax

#### #163, enacted March 20, 1911

An Ordinance repealing Ordinance #19 of the Borough of Bangor entitled "worldly employment or business on Sunday prohibited" approved the third day of January 1889.

#### #166, enacted March 20, 1911

An Ordinance defining additional duties of the high constable and fixing the salary of the high constable, the same to be in lieu of all fees.

#### #525, enacted June 7, 1965

An Ordinance establishing an indoor recreation center to be known as "Bangor Civic Center" and providing for the maintenance and regulation thereof.

#### #528, enacted December 6, 1965

An Ordinance amending Ordinance No. 525 enacted June 7, 1965 entitled "An Ordinance establishing an indoor recreation center to be known as "Bangor Civic Center" and providing for the maintenance and regulation thereof." So as to substitute the works "Bangor Cultural Center" for the words "Bangor Civic Center" through the Ordinance.

## Section 2. Severability

If any section, sub-section, provision, regulation, limitation, restriction, sentence, clause phrase or word in this Ordinance is declared by any reason to be illegal, unconstitutional, or invalid by any court of competent jurisdiction, such decision shall not affect or impair the validity of this Ordinance as a whole, or any other section, sub-section, provision, regulation, limitation, restriction, sentence, clause, phrase, word or remaining portion of this Ordinance. Borough Council hereby declares that it would have adopted this Ordinance and each section, sub-section, phrase and word thereof, irrespective of the fact that any one or more of the sections, sub-sections, provisions, regulations, limitations, restrictions, sentences, clauses, phrases or words may be declared illegal, unconstitutional or invalid.

#### Section 3. Effective Date

This Ordinance shall take effect immediately upon its adoption.
