*Brendan Stanton, WWTP EQ Tank Electrical Contract, Payment App. No. 5* - A **MOTION** was made by Capone, seconded by Augustine to approve the Brendan Stanton, Inc. Payment App. #5 in the amount of \$63,091.88. All were in favor, **MOTION** carried.
